## 6. BAPLIE/MOVINS 3.0

Henrik asked for test messages.

Then a discussion follows about the implementation of the new versions of BAPLIE and MOVINS. The implementation guides are stable so that implementations can start. However, the terminals have no request yet for these new messages.

Michael Haddon makes suggestions for the optimization of the cooperation between the line's central planner and the terminal. The central planner creates the pre-stow without any knowledge about the stack on the terminal and he believes this process can be optimized.

## 7. Verified Gross Mass (VGM)

Yesterday this subject was discussed at length during the sub-group meeting and several sub-group meetings have taken place during the last few months. Jost presents the results. (See: [VGM-Malmö-20150401.pdf](#))

Topic:

IMO's Maritime Safety Committee approved changes to the Safety Of Life At Sea (SOLAS) convention regarding a mandatory container weight verification requirement on shippers.

This means containers of which the Verified Gross Mass (VGM = gross weight of cargo + container tare) cannot be positively identified may not be loaded on board of vessels. Implementation before 1-July-2016.

The Shipper is the responsible party and the Line must make sure that the VGM for all containers to be loaded are known and verified, otherwise a loading instruction may not be given to the terminal.

The discussions in SMDG are about two subjects:

1. Procedural: who will do what and when?
2. Technical: how can we transmit the VGM and the details about the authorized party in the message types under control of SMDG?

In order to be able to implement the necessary systems update in time we must define the specifications as soon as possible, say before the end of June this year. We must try to avoid structural changes to message types or the need for a new message. Jost, however, is already considering to develop a new message (VERMAS) which can be used to transmit the VGM together with details about the authorized party. It is therefore of utmost importance that we urgently define the most important use cases and identify the amendments to be made to the SMDG messages BAPLIE, MOVINS, COPRAR, COPARN, etc.etc.

COXXXX 2.x versions: Paul

IFTXXX: Yoshi and Robert
